

Notes:

1. The walling system can either be constructed as a straight walling system or incorporate 90 or 270 degree angles. This angle is measured between the attack faces of the two adjacent panels.
2. The minimum height of partitioning systems incorporating doorsets is 1.0 m.
3. The minimum width of walls incorporating doorsets is 0.63 m.
4. The minimum height of partitioning systems formed with a ceiling and incorporating doorsets is 1.1 m.
5. The doorsets are not designed to be fitted within the ceiling system
6. The partitioning system's resistance relies on the supporting substrate offering compatible resistance to manual attack.
7. The Steelway security mesh panel systems are approved when installed in accordance with the instructions detailed in documents E-INST002/SWAY (Issue 5) and E-INST003/SWAY (Issue 5).
